4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation. After skin contact: Repeated or prolonged excessive exposure may cause irritation or sensitization dermatitis in previously exposed individuals. After ingestion: Ingestion may cause irritation of mouth, throat, digestive tract, diarrhea and vomiting.
Harmful if swallowed. After inhalation: Unlikely to occur due to the physical properties of the product.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures
