### 4. FIRST AID MEASURES

#### Description of necessary measures

**Inhalation:** First aid measures not required.  
**Skin contact:** First aid measures not required. Cosmetic product and therefore not necessary.

#### Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation, with possibility of corneal injury. After inhalation: Unlikely to occur due to the physical properties of the product. At elevated temperatures, vapors or mists may cause irritation.
